

**MINUTES OF THE PUBLIC HEARING AND SPECIAL MEETING OF THE BOARD OF COUNTY
COMMISSIONERS, CLARK COUNTY, IDAHO**

June 21, 2023

EXECUTIVE SESSION

The Commissioners met in Executive Session per 74-206(1)(a) to interview applicants for the Road & Bridge Supervisor position. Executive Session began at 2:30 pm with the entire Board in attendance. The Executive Session ended at 3:15 pm.

PUBLIC HEARING

The Board called this Public Hearing for the purpose of amending the Clark County Floodplain Ordinance and also for an action item for the purchase of a truck from the City of Dubois to be used as the coroner vehicle.

The Hearing was called to order at 4:00 PM with Commissioners MaCoy Ward, Nick Hillman, and Greg Shenton, and Clerk Camille Messick, and Emergency Manager Sheree Farr in attendance.

The Public Hearing portion was recorded via voice recorder. The record shows that no members of the public were present at the Hearing. Notice of the Hearing was published in the Jefferson Star for the previous two weeks. No written comments were received.

Sheree Farr explained the changes to the Floodplain Ordinance, which were to bring the Ordinance back into compliance with FEMA. The changes were written by County Attorney Weston Davis. No further discussion was held.

Commissioner Ward made a motion to adopt the new Chapter 11 County Floodplain. Commissioner Hillman seconded the motion. After a unanimous vote, the motion was passed. Roll Call was taken: Commissioner Shenton "Aye", Commissioner Hillman "Aye", and Commissioner Ward "Aye".

The Hearing was completed at 4:10 pm.

CORONER VEHICLE

Discussion was held on the possibility of purchasing a truck from the City of Dubois to convert to be the Coroner's Vehicle.

Commissioner Ward made a motion to purchase the F-250 Ford pickup from the City of Dubois for \$13,000 pending the approval of the Coroner. Commissioner Hillman seconded the motion and after no further discussion, the motion was passed by unanimous vote.

Further discussion was held regarding Public Health Board Member nominations. The Commissioners expressed support and signed the submitted nominations for board members presented by the Eastern Idaho Public Health Board of Health. The nominees were Fremont County Commissioner Blair Dance and Bonneville County Commissioner John Walker.
