ROAD & BRIDGE UPDATE

Kevin Hathaway, road and bridge supervisor met with the Board to update them on his department. Mr. Hathaway reported to the Board that he is currently applying for LHTAC grants for Medicine Lodge Road improvements. The Board reviewed the 2008-09 budget with Mr. Hathaway.

ECONOMIC DEVELOPMENT UPDATE

Kerri Ellis, economic development professional met with the Board to update them on her department. The Board requested from Alltel Communications to extend the site agreement until December 31, 2009 to continue to collect anemometer data. Commissioner May made the motion to request temporary permits from Forest Service, Bureau of Land Management and Department of Lands to place anemometers on public lands, seconded by Commissioner Leonardson, unanimous.

BUREAU OF LAND MANAGEMENT

Bob Mallett representing the Bureau of Land Management met with the Board to update them on the new buildings in Dubois. Mr. Mallett will draft a Memorandum of Understanding to move the fire department into the building.

IDAHO DEPARTMENT WATER RESOURCES

Mary McGown, State Flood Plain Coordinator and Barbara McEvoy, Flood Plain Specialist met with the Board to review the National Flood Insurance Program. The county ordinance will need to be updated.

4-H LIVESTOCK COUNCIL

Kelli Whittier representing the 4-H Livestock Council met with the Board to request permission to replace the fence around the livestock building. The Board granted said request.

COUNTY EMERGENCY SERVICES

Virgil Valantine, civil defense director met with the Board to review the PSIC grant award that the county received and the contract with Teton Communications.

LIQUOR CATERING PERMIT

Lisa Black, clerk met with the Board to request a liquor catering permit for the rodeo September 6, 2008. Commissioner Leonardson made the motion to approve a liquor catering permit at no charge to the Clark County Rodeo Club for the rodeo September 6 2008 providing they provide the proper state license, seconded by Commissioner May, unanimous.

FAIRGROUND USE FOR SHEEP SALE

Quinn Jacobson mailed a request to use the fairgrounds and community center for their annual sheep sale on September 18, 2008. They asked if they could use the grounds September 17-19 for setup and cleanup. The Board agreed to their request.

OCTOBER MEETING CHANGE

Commissioner May made the motion to change the October meeting to October 14, 2008, due to the fact that Columbus Day falls on the second Monday of the month, which is the normal meeting day, seconded by Commissioner Shenton, unanimous.

KILGORE WINTER PLOWING

The Board discussed Hillman's request to keep the road open from the Kilgore Store to their property during the winter. The Board decided that due to budget constraints it is not in the public's best interest to plow from the Kilgore store to Hillman's property. The Board directed Prosecutor Simpson to draft letter to Hillman's stating the Board's position for their review and signature.

SHERIFF UPDATE

Craig King, Sheriff met with the Board to update them on his department. Commissioner Leonardson made the motion to purchase three sets of tires and additional ammunition

out of the 2007-08 budget, seconded by Commissioner May, unanimous. Commissioner Shenton made the motion to deposit \$3000 from a civil case forfeiture into the Sheriff's trust account for drug enforcement, seconded by Commissioner Leonardson, unanimous.
