MINUTES OF THE REGULAR MEETING OF THE BOARD OF COUNTY COMMISSIONERS CLARK COUNTY, IDAHO AUGUST 8, 1988 The Board met this day in regular session. Present were Commissioners J. Albert Laird, George H. Whittaker and Charles R. Vadnais, Prosecuting Attorney Jack G. Voshell and Clerk Jo Ann S. Tavenner.

MINUTES

Motion by Commissioner Vadnais, seconded by Commissioner Whittaker, unanimous that the minutes of the last regular meeting on July 11,1988, be approved as written.

LANDFILL FOR DUBOIS

Keith Tweedie, City Council member and Richard Hunter met with the board concerning the landfill west of Dubois. Tweedie said that if the City is not allowed to take the topsoil from the landfill area they will need another source to obtain topsoil to fill the burial plots at the Dubois cemetery. Hunter said that the topsoil runs from one to two feetin that area. The county alleges that they need soil to cover the landfill area when it is full.

After a short discussion it was unanimous agreed by all present that the City will take the topsoil just ahead of the opening on the landfill and return and stock pile the soil removed from the graves to the landfill area to be used by the County to cover the landfill. The County will stockpile the topsoil, when they open a new area at the pit, for the Cities use at the cemetery.

CATTLEGUARD AT SPENCER ON OLD 91 ROAD

Ted Edwards, Mayor of City of Spencer, met with the Board concerning the installation of the cattleguard on old 91 road north of Spencer. The Board informed Edwards that this has been discussed with Mike Case from the Forest Service and they told him the County is will to furnish the equipment and labor, but they feel the permittee should be willing to pay for the concrete that goes in the base. As of this time they have not heard back from Mr. Case.

After a short discussion it was decided that maybe the permittee was not contacted and that Commissioner Laird would contact him and get back to the board.

Edwards also updated the Commission on the wells being drilled at Spencer and said they are getting the property boundary problems solved.

APPROACH NEEDED TO PROPERTY

Norman Hooper met with the Commission and request that the county put an approach off the frontage road to his property. The Board will inform the Road & Bridge Supervisor, Eldridge Russell of same.

UPDATE ON WEED DEPARTMENT

Dan Lucas, Extension Agent, met with the Board and filled them in on the chemical spill accident at the U. S. Sheep Station. Also a discussion was held on leafy spurge patches in the Kilgore and Spencer

Lucas informed the Commission that he is still forming an Advisory Committee and stated that he would like all three board members to be on this committee. It was unanimous they would all be willing to serve on the Advisory Committee.

CANCELLATION OF WARRANT

Jo Ann S. Tavenner, County Auditor, requested that the Board cancel warrant # 88-00911 made payable to the District Seven Health Department, dated 6/13/88 in the amount of \$4488.00. Reason for the cancellation is that it an overpayment as the county has already paid this billing for 1988.

Motion by Commissioner Vadnais, seconded by Commissioner Whittaker, unanimous that warrant #88-00911 is hereby cancelled.

MEDICARE PAYMENT ON AMBULANCE PATIENTS

It was brought to the Commissions attention that Medicare and Medicaid only pay eighty percent of the bills on ambulance calls this leaving twenty percent of the bill unpaid. Commissioner Vadnais reported that the Dubois Lions Club stood that loss. After a short discussion it was moved by Commissioner Vadnais, seconded by Commission Whittaker unanimous that the county endure the twenty percent loss on Medicare and Medicaid patients as long as the county can tolerate it.

EMERGENCY FOOD & SHELTER FUNDS

A short discussion was held on the emergency food and shelter funds, that the county has recently received from the federal level. It was reported to the board that some of the counties are using this funds to set up food pantries and obtain deep freezes to store wildgame donated to the county by Fish & Game for illegal game taken.

Motion by Commissioner Whittaker, seconded by Commissioner Vadnais, unanimous that the welfare director be authorized to use funds to buy a deep freeze and start a food pantry to help the people that are eligible under this program.

1988-89 BUDGETS

The Board reviewed and cut some department budgets. Final review and balancing of the budget will be done at the September 12, 1988 meeting.
