MINUTES OF THE REGULAR MEETING OF THE BOARD OF COUNTY COMMISSIONERS

CLARK COUNTY, IDAHO

JUNE 13, 1988

The Board met this day in regular session. Present were Commissioners J. Albert Laird, George H. Whittaker and Charles R. Vadnais, Prosecuting Attorney Jack G. Voshell and Clerk Jo Ann S. Tavenner.

MINUTES

Motion by Commissioner Whittaker, seconded by Commissioner Vadnais, unanimous that the minutes of the last regular meeting of the Board on May 9, 1988, and the special meeting on June 3, 1988 for canvassing votes be approved as written.

CATTLEGUARD NORTH OF SPENCER

Mike Cass, Range Conservatist, from the U. S. Forest Service met with the Board concerning trouble with cattle coming down to water at the bottom of Huntley; and if they had a cattleguard installed at the top or crest of the hill on old Highway 91 or the frontage road N. of Spencer this would solve the problem.

Cass said that the Department of Transportation removed some cattleguards from the exchange at Roberts and which are in a stockpile at Rigby and he was sure the county could buy one for this purpose. He said they would also need to pour a base out of concrete under the cattleguard which would probably cost around \$250 and that the someone would need to go to Rigby to get the cattleguards.

After a short discussion it was decided that the Commission would look into and get back to Mike. However they feel that the individuals that will be benefiting most from the cattleguard should pay for the bases as the county will be furnishing the cattleguard and the equipment for installion of cattleguard.

GRAVEL CRUSHER

Orlin Gunderson, met with the Commission and discussed renting a small gravel crusher, he said it would cost \$10,000 per month plus paying for the transport costs one way from Kent Washington. He said he would be needing one in about two and one-half months in Salmon and though the county would be interested in sharing costs. He also mentioned to the commission that Power County has a small crusher for sale, which includes set of rollers and cones, for around \$30,000.

After a short discussion it was unanimous that the Commission would have to check with the Road & Bridge Supervisor and see what road construction is planned and what the needs for crushed gravel are.

ADDITIONAL FEE FOR MOTOR VEHICLE LICENSURE

Betty Kirkpatrick, County Assessor met with the Commission relating to additional fees on motor vehicle licensure. Kirkpatrick said with the passing of Amended Senate Bill No. 1340 which revises Section 31-870 I.C. and allows the board of county commissioners to impose and collect fees for those services provided by the county which would otherwise be funded by ad valorem tax revenues.

Kirkpatrick said most of the counties are going to charge \$2.00 per registration.

THE FOLLOWING WAS DULY APPROVED AND ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS ON THIS 13th day of June, 1988.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS, CLARK COUNTY, STATE OF IDAHO that starting July 1, 1988, we do now impose a collect fee of \$2.00 per registration on all motor vehicle to be collected by the assessor and funds be used to help cover the cost of the service being rendered. Motion by Commissioner Whittaker, seconded by Commissioner Vadnais, unanimous that the previous statement is hereby adopted.

CHRISTENSEN FENCING RIGHT OF WAY

It was brought the the Board attention that Thomas Christensen is fencing right of way on Middle Creek road that runs through his property. Road & Bridge Supervisor, Eldridge Russell said the Right of Way in that area is sixty-six feet.

After a short discussion it was unanimous that Jack Voshell write or contact Mr. Christensen and discuss the problem.

RESOLUTION ADPOTED ON USE OF SAFETY BELT

THE FOLLOWING RESOLUTION WAS DULY APPROVED AND ADOPTED BY BOARD OF COUNTY COMMISSIONERS on this 13th day of June 1988.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS, CLARK COUNTY, STATE OF IDAHO:

- Section 1. That use of safety belts in all county vehicles so equipment shall be mandatory.
- Section 2. That all county employees are also urged to use safety belts in their private vehicles during non-work hours.
- Section 3. That this Resolution shall be in full force and effect immediately upon the adoption and approval.

HAZARDOUS MATERIAL ANNEX

Donald W. Shenton, Civil Defense Director, met with the commission and reported that he had received a letter from Richard Horne, District Seven Health Department, he said that Horne was having a Emergency Management meeting on hazardous materials in Idaho Falls on June 17 at the Little Tree Inn, also that the board needs to add a Hazardous Material Annex to the Emergency Plan and select a coordinator.

After a short discussion it was suggested by the Board that Shenton involve Craig King, Dan Lucas and Eldridge Russell in this hazardous material schooling as they could, at one time or another, all be working with these materials. Also it was suggest that we go in conjunction with Jefferson County on a coordinator.
