Commissioner Ward moved and Commissioner Hillman seconded to appoint Greg Shenton to continue as the Chair of the Board of County Commissioners. After a unanimous vote, the motion passed.

Commissioner Ward motioned and Commissioner Hillman seconded to accept the tire bid from Big O Tires for \$2,872.00. After a unanimous vote, the motion passed.
