INSURANCE REPRESENTATIVE FOR COUNTY

David Leonardson, David Leonardson Insurance Co., met with the Commission and request that he be considered as local agent to represent the county through ICRMP. Leonardson said the board would need to send a broker agent letter to ICRMP endorsing him if they were in agreeance to changing agents.

No decision made at this time.

LEASING NEW DUMP TRUCK

Darrell Ogden, Goode Motor Company Representative, met with the Board and presented them with a lease on a 1989-LT9000-C&C Ford+Dump+Pull-Pup Trailer. Truck would have an extended frame for a plow, telescope hose, load sensor pump, dump-bed would have a heavy duty tailgate and pup trailer with 8 yard capacity and spreader bar for \$89,586.00 on a 60 months lease w/h interest at the rate of 8.35%.

After a length discussion it was moved by Commissioner Whittaker, seconded by Commissioner Vadnais, unanimous that the county enter into a lease agreement with Goode Motor Company for \$89,586.00 plus interest on the 1989 Ford+Dump+Pull-Pup Trailer.

INDIGENT CASE #201

The Board was brought up to date on Indigent Case #201 as the board has never received a completed application back from the applicant the case was turned back to Prosecuting Attorney, Jack Voshell to contact the applicant and his creditors stating that the county will denie the claim if a completed application is not received by the next board meeting.

COUNTY INSURANCE

Mike Jepsen met with the Commission and explained that ARPCO had closed there doors and moved out of state. Jepsen said not to blame ICRMP as ARPCO didn't touch all bases and couldn't met the requirements request to receive state license. He reported that ICRMP is putting together a similiar program to last year and that December 15, 1988 is the deadline for completion.

Jepsen also presented the Board with a purposed coverage through the Hartford program covering all auto, property, police, professional etc. for a Cost of \$28,026. Jepsen said that this policy wouldn't cover pollution.

After reviewing the problems and times its was unanimous that the Board feels at this time the county should stay with Mike Jepsen, as agent for the time being.
