ROAD & BRIDGE UPDATE

Kevin Hathaway, road and bridge supervisor met with the Board to update them on his department. Mr. Hathaway gave an updated road report to the Board. Mr. Hathaway reported to the Board that he is continuing to work on LHTAC grants for Medicine Lodge Road improvements. Mr. Hathaway reported that he has contracted a new cellular phone plan for the road and bridge department. Mr. Hathaway informed the board that additional fuel will need to be ordered this week. Discussion was held on seasonal, full-time, and part-time employees.

WEED UPDATE

Bo Billman, weed supervisor met with the Board to inquire about the use of the weed revolving trust funds. Mr. Billman also inquired about the requirements on hiring county employees.

BUREAU OF LAND MANAGEMENT

Wendy Reynolds, Field Manager and Terri Smith, Project Leader representing Bureau of Land Management met with the Board to review county's current plan and update them on future travel management.

MOTOR VEHICLE UPDATE

Carrie May, assessor and Craig King, sheriff met with the Board to notify them of changes effective January 2009 requiring restricted vehicle plates and off-highway stickers on all ATV, UTV and motorbikes. The restricted plate will give allowance to drive on county roads but not on state highways. Plates will have to be purchased at county assessor offices; vendors will not be selling these plates. Discussion was held on locations permitting crossing of state highways that will require approval of the Idaho Transportation Department and signage.

ASSESSOR UPDATE

Carrie May, assessor met with the Board to notify them that the assessor office had a \$60 shortage on September 4, 2008. The assessor under/overage account did not have adequate funds to utilize. The Board was advised by Ferrell Steiner, auditor that the under/overage account could not go negative and to use the assessor miscellaneous budget instead. Commissioner Leonardson made the motion to purchase a Dell computer for \$1075.48 for the assessor's office using the 2007-08 general capital computer budget, seconded by Commissioner May, unanimous.

ECONOMIC DEVELOPMENT UPDATE

Kerri Ellis, economic development professional met with the Board to update them on her department. Commissioner Shenton made the motion to purchase parts for the anemometers for \$425, seconded by Commissioner Leonardson, unanimous. Ms. Ellis expressed concerns regarding the qualifications of the migrant housing and also her concerns on the status of the dehydration plant.

TETON COMMUNICATIONS

Tony Hafla, representing Teton Communications via telephone, Virgil Valantine, civil defense director, and Craig King, sheriff met with the Board to review the PSIC grant award.
