The Board met this day in regular session. Present were Commissioners J. Albert Laird, George H. Whittaker and Charles R. Vadnais, Presecuting Attorney Jack G. Voshell and Clerk Jo Ann S. Tavenner.

#### MINUTES

Motion by Commissioner Whittaker, seconded by Commissioner Vadnais, unanimous that the minutes of the last regular meeting of the Board on December 14, 1987, be approved as written.

# COUNTY WILL ACCEPT CITY SANITARY LANDFILL

The Board was informed that the City of Dubois owns land west of the City sanitary landfill which contains approximately 32 acres, and that the City of Dubois would be willing to deed this ground to the county with except the City of Dubois, reserves the right to remove the top soil from the subject premises to use for filling burial plots at the Dubois cmetery.

After a short discussion it was unanimous that the county would allow this exception so long as the taking of said top soil does not interfere with the County use of the premises as a dump and sanitary landfill, for which zoning restrictions and regulations are hereby waived by the City.

#### ADVISORY COMMITTEE

Daniel Lucas, Extension Agent, met with the commission and advised them he would like to form an advisory committee involving the board and people from through the community on what he should be doing and what is need through the county to better the community.

# SHERIFF'S & CLERK'S QUARTERLY REPORTS

After examining the Sheriff's & Clerk's Quarterly Reports it was moved by Commissioner Vadnais, seconded by Commissioner Whittaker unanimous that quarterly reports be approved as presented.

#### MUTUAL AID AGREEMENT BETWEEN INTRALOCAL GOVERNMENTS

After reviewing the mutual aid agreement concerning law enforcement between counties the agreement was signed by the board.

#### MISSED ROLL APPROVED

The board met also in session as a Board of Equalization for the missed assessment roll. There being no protest it was moved by Commissioner

Whittaker, seconded by Commissioner Vadnais, unanimous that the roll be approved as received.

#### BOARD RECOMMENDS JURY COMMISSIONER & DEPUTY

With the moving of Sharon Cummins the county needs a new jury commissioner. After a short discussion it was unanimous that the Carol Hoopes be recommeded as Jury Commissioner and Judy Lingo be recommeded as Deputy.

#### TRACK LOADER NEEDS NEW MOTOR

Eldridge Russell, Road & Bridge Supervisor, met with the board concerning new motor for the track loader. Russell said that he had been talking to Vern Jensen and that he could get the county a new motor for around \$4500.00. After a short discussion it was unanimous that the county would purchase the new motor at this price.

### ELECTION PRECINCT BOUNDARIES

After reviewing the election precinct boundaries the commission was unanimous that boundaries should remain the same; no change at this time.
