# December 14, 1998

The board met this day in regular session. Those present were Commissioners' Charles R. Vadnais, Charles E. Wilson and Gregory A. Shenton, Prosecuting Attorney Craig Simpson, Clerk Jo Ann S. Tavenner and Newly elected Commissioner Ted Edwards.

#### WEED CONTROL

Keith Tweedie, Weed Supervisor, met with the Commission concerning goals and needs for the 1999 season. The group discussed the possibility of putting Keith Tweedie on full time and what would have to be done. They were informed that due to this department being seasonal on employees benefits like PERSI and other fringe benefits were not set up for fiscal year 1998-99, that a full time employee would receive. They were advised that they would have to open the budget or wait and set it up benefits next year. Group decided to wait until next year.

It was unanimous that Keith Tweedie is Supervisor over the Weed Department and a letter will be drafted and sent to all department employees explaining that Keith is in charge of all purchases of chemical expenditures and work assignment etc. in this department. Tweedie requested permission to go through the surplus property and put it up for sale. Permission was granted.

# **CLOUD SEEDING**

Conni Owen met with the Commission and they went over the Cloud seeding program. She said that they seeded every place except upper Medicine Lodge on the 4th and 5 of December.

#### EXECUTIVE SESSION

The Board at this time went into executive session to interview and pick a person to fill the Clerk of the District Court vacancy left by the death of Vickie Ker. Three candidates were interview. It was unanimous that due to outstanding qualifications Conni Owen be appointed Clerk of the District Court to fill the unexpired term of Vickie Ker. Owen will be required to file for the position in the 2000 election.

## JUVENILE DETENTION GRANT

Jerry Riley, Detention Center Director, met with the Commission concerning a new grant called juvenile accountability block grant. From this grant Clark county stands to receive \$1229.00. Riley said that if all counties approve of pooling the money from this grant can be used for much needed construction projects at the Detention facility. He presented the board with a detailed allocated costs for additional construction at the five-county detention center. After some discussion it was unanimous that this board joins with other counties on pooling funds for need construction at the center.

# 1992 ENDLOADER BIDS AWARDED

The Board having advertised for bids to be opened at this time on one surplus 1992 Cat front endloader. The Board received two bids as follows:

## ANIMAL DAMAGE BOARD

Bill Shivley, representative from the Animal Damage Control Board met with the Commission concerning help with funding. He said that Clark, Lemhi, Butte, Fremont, Madison, Bonneville and Jefferson should all share in the cost and that Clark has not participated. Shivley said the funds go towards hire an airplane and trappers to shoot and trap coyotes in this area. Motion by Commissioner Shenton, seconded by Commissioner Wilson, unanimous that Clark County take \$1000 from the Range Improvement fund and send to the Animal Damage Control Dist. Board to help fund this program.

**RESOLUTION NO. 98-07** 

It has been unanimously approved and agreed upon by the Clark County Commissioners to acquire the use of and finance through First Security Bank, N.A., the generally described as New 1998 Caterpillar Model 950G Wheel Loader costing \$160,175.00 for a term of 4 years, at 5.30 % annual percentage rate. There will be 1 Annual payment of \$101,724.00, followed by 4 payments of \$16,724.00.

Charles R. Vadnais has been authorized to sign the necessary documents on behalf of Clark County.

Rod Belcher, Road & Bridge Supervisor, met with the Commissioners to up date them on his department. Belcher said he needs to do repairs on the diversion dam bridge on Camas Creek. Hopes to do right away. He said he received a request to have the county plow snow into the house at the Bennett place. He said they are willing to pay. Belcher said that he wouldn't have a problem if the owner keep the snow pushed back in their vard.

He said that Reed Rick's still has his cows out up Crooked Creek. The group discussed the clean up of the Cinder Pit and the cost of it. Belcher said that the State furnished the seed so there was only Grovers costs. He said the design called for dirt, not cinder on the shoulders so that is what they used.

The Board reviewed Case No. 98-05 for the second time at the request of Donna Parkinson. hospital representative, from Madison Memorial.
