MINUTES OF THE REGULAR MEETING OF THE BOARD OF COUNTY COMMISSIONERS

# CLARK COUNTY, IDAHO

## AUGUST 10, 1987

The Board met this day in regular session. Present were Commissioners J. Albert Laird, George H. Whittaker and Charles R. Vadnais, Prosecuting Attorney Stevan Thompson, and Clerk Jo Ann S. Tavenner.

#### MINUTES

Motion by Commissioner Vadnais, seconded by Commissioner Whittaker, that the minutes of the last regular meeting of the Board on July 13, 1987, be approved as written.

### TRAFFIC CAUSES DUST PROBLEM

Bettie Larick met with the Board requesting help from the County or Forest Service, to help control the dust on road-ways by her home at Kilgore. She said there is a logging or hay truck going or coming every 5 minutes all day. The Board requested that Ed Russell, Road and Bridge Foreman, be called in. Russell said he had checked into the problem and a dust oil called Magnism Cloride: delivered and shot would cost around \$71.50 per ton and it would take 38 ton. Also, would need a second shot the following season which would cost around \$1500.00. This treatment is good for about 3 years.

### JACOBY ROAD TO RECEIVE CATTLEGUARDS

The Board discussed Jacoby road and the need to put it on the county road system. It was unanimous to have the Road and Bridge crew put cattleguards at both ends, so it would qualify for the County road system. Board requested Road and Bridge Foreman be informed.

## MEDICAL INDIGENT CASE DENIED

The Board read and considered the application for Indigent Medical assistance filed by Pat Bennett on July 1, 1987. A claim for medical services has been filed by Eastern Idaho Regional Medical Center, in the amount of \$6736.26 for services rendered Mr. Bennett. Having considered the application the Board voted unanimously to reject the application and deny the claim made by the hospital. The County Attorney was directed to address a letter to the applicants stating the reasons for such denial. The applicant, Pat Bennett, is not indigent with \$300.00 per month income after expenses. In addition, the applicant did not receive emergency medical services and failed to file a pre-hospitalization application as required by Idaho Code Section 31-3404.

### 1988 BUDGETS

The Board reviewed and cut some of the budget from each department due to the possiblity of a 67% cut back on Union Pacific valuation and loss

and cuts of revenues from other sources such as Revenue Sharing, Liquor Apportionment. The Board reviewed and cut some of the department. Final review and balancing of the budget will be done at the Sept. 14,1987, meeting.

### WEED DEPARTMENT NEEDS NEW VEHICLE

The Board dicussed the need of a new 4-wheel drive for the weed rig. The Clerk was asked to check and see what could be found.

## CONTRACT RE-NEWED

The Board reveiwed and signed a new contract with Swager & Swager Accountant firm for Auditing the County books.
