Discussion proceeded regarding Sheriff Vehicle trade-in values for the existing vehicles owned by the county, and options for new trucks to purchase. Further discussion was held regarding the possibility of selling the existing sheriff truck to Road and Bridge for a similar value.

Quotes were brought before the Board for 3 different options from dealers Hirnings and Dave Smith.

It was decided to approve action for ordering a vehicle and offering the existing vehicle to Road and Bridge as an option for that department to purchase.

Commissioner Ward made a motion to approve ordering the pickup from Hirnings for \$68,884.00 and to offer the Sheriff's Deputy Vehicle, a 2017 Ford to the Clark County Road and Bridge Department as an option for purchase for the trade-in value of \$45,000 or more. Commissioner Hillman seconded the motion. After a unanimous vote, the motion was approved.
